First, learn more about the Green New Deal by watching this <u>video</u>. If you live outside of the US, research to see if your country has a similar major climate action plan in the works.

The most recent and major action in my country that is not irrelevant to climate crisis is the approval of the "Protocol for the Protection of the Biodiversity of the Caspian Sea" in the Islamic Consultative Assembly. This protocol was approved in 16/10/2021, and seems to be a useful and necessary one since Caspian Sea was hurt a lot in the past few years. What are its most important components?

It's a join t program among countries which benefit from the Caspian Sea: Iran, Turkmenistan, Russia, Kazakhstan, and Azerbaijan. Aims:

- A) Conservation of endangered species and vulnerable ecosystems to ensure their longevity and biodiversity.
- B) To prevent the reduction, degradation and destruction of species, habitats and ecological systems in accordance with the precautionary principle.
- C) Protecting and conserving areas that best offer a wide range of species,
- special habitats, ecological systems and related natural and cultural

# Important Regulations:

- A) Monitor sources of contamination and any activity that may or may not have a significant adverse effect on habitats and species.
- B) Use the natural resources of the Caspian Sea in a way that does not harm the marine environment and biological resources of the Caspian Sea.

# Important safeguards:

- A) Organize activities that have adverse effects on protected species and their habitats, and other measures that ensure a favorable conservation status of such species.
- B) Intentionally and as far as possible accidental survival, acquisition or killing, transfer and exploitation of protected plant and animal species, monitor their components and derivatives for commercial purposes and, where appropriate, prevent such acts.
- C) Monitor and prevent disturbance to animal species, especially during the breeding, hatching, hibernation or migration periods, as well as during other periods of stress.
- D) Organize all forms of degradation and disturbance for the protected plant species, their components and products, including their collection, harvesting, cutting, eradication, acquisition, trade or transfer and supply for commercial purposes.
- E) Examine the status of all alien species found in the Caspian Sea and the hazards posed by them, and develop and implement a regional action plan for the species that have been identified as invasive.

Is there anything you would like to see added or removed?

I believe in the part "Monitor sources of contamination and any activity that may or may not have a significant adverse effect on habitats and species" it would have been better if strict rules that should be imposed on industries was addressed, too, so all the ways of taking this regulation for granted was blocked and no excuse would have been accepted.

What issues do you think should be addressed first?

The A regulating, which is Monitoring sources of contamination as well as examining the status of all alien species found in Caspian Sea are of high importance.
