Subject: Urgent Appeal for Adequate Support for Helena-West Helena's Water Crisis

I hope this letter finds you well and in good spirits. demographics. It is crucial to recognize that every Arkansan, regardless of where they live or their background, deserves equal access to clean drinking water and essential services.
