 - e. Threaten the Great Maya Aquifer

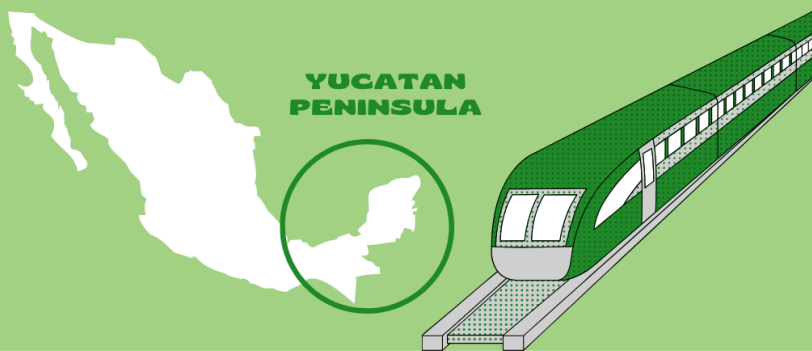
Indigenous communities rely on the environment for their subsistence and cultural practices, so any damage to the environment could have a significant impact
