Unfortunately, the major downside of chemical sunscreens is that they contain more harmful ingredients, such as PABA, oxybenzone, and octinoxate. While chemical sunscreens may be less visible on the skin, some chemical UV filters may enter the bloodstream and are linked to health effects such as endocrine disruption and skin irritation. Additionally, they may lead to various toxicological impacts on marine life and coral reefs bleaching. Oxybenzone has also been linked to breast cancer, Hirschsprung's disease, and endometriosis.
